Subject: - Grant of renwal of temporary affiliation for running B. A Fazilat Degree Programme for the session 2021-22, 2022-23 and 2023-24 retrospectively.

Sir,

Pursuant to the report of the Inspection Committee dated December 1, 2023 and in anticipation of the approval of the competent body, the Vice Chancellor has been pleased to authorize to recommends grant of renewal of temporary affiliation retrospectively in favour of Jamia Siraj-ul-Uloom for the academic session 2021-22, 2022-23 and for the current academic year 2023-24 with an intake capacity of 60 seats, subject to the fulfillment of the following conditions. The University is vested with the authority to withdraw the affiliation as per the relevant sections of the Kashmir & Jammu Universities Act 1969 and concerned statutes, if the college fails to meet the conditions laid down by the visiting inspection team of experts:-

- 1. Seek NOC from Higher Education Department, Govt. of J&K for academic session 2023-24.
- 2. Seek renewal of temporary affiliation on year to year basis in future.
- 3. Appoint requisite faculty and other staff members on regular basis after following the due process and as per the essential qualification specified by the UGC/University on priority basis who shall be paid salary strictly as per the pay scales notified by affiliating University.
- 4. Salary to the teaching staff should be paid through bank only and every month the bank statements reflecting salary paid duly signed by the concerned bank manager should be forwarded to Dean, CDC office every month.
- 5. The College should improve and upgrade the computer lab with broadband and backup facility and by adding 10 more systems and 2 Printers.

- 6. Revamp and Upgrade the seating capacity of central Library. Besides, the Library should be fully automated using SOUL 2.0 or any other suitable software. The college should add books of different titles on each subject of the proposed programme as prescribed in the NEP to include both text books and reference books, along with a book bank facility for students. Besides college should also subscribe relevant magazines for the Library.
- 7. Develop a toilet facility for specially-abled persons in each floor of the academic block. Construct ramps on the entrance of the main building.
- 8. Immediately create safe drinking water facilities and install fire extinguishers and all the staff members be trained to use fire extinguishers.
- 9. Adhere to the rules and regulations governing the admission and examination of the programme as prescribed by the regulatory bodies viz UGC/affiliating University.
- 10. The College shall mobilize all available resources to motivate and attract the students for admission purpose.
- 11. Pay the affiliation fee as prescribed by the University
